General

- 1. This Addendum shall supplement, amend, and become part of the Bid Documents. All Bids and the Construction Contract shall be based on these modifications.
- 2. Bidders shall acknowledge the receipt of this addendum on their Bid Form.

Questions and answers from bid questions submitted by contractors after the mandatory pre-bid meeting and before the question closing date:

Question 1: Would it be acceptable to submit copies of the bid documents and bid bond at bid time if the originals were in the mail? Or would emailed bids be acceptable?

Response: Per the contract documents: "Sealed proposals will be received by the City Clerk of the City of Mobile, Alabama, 205 Government Street, 9th Floor, South Tower, until 2:30 p.m. local time, March 15th, 2023 and then publicly opened and read in the atrium on the 1st floor of the Mobile Government Plaza."

Question 2: Is there any possibility that the bid date could get pushed back a week?

Response: The bid opening date will not be extended.

Changes to the Contract Specifications:

1. On page 41 of the Specifications, the following paragraph shall be added to the end of item 8., "SECTION 600, MOBILIZATION, SUB-SECTION 600.01:

"The Contractor shall provide weekly, safe, and reasonable means of transportation to and from the marine work sites, staging areas, and other work areas for the Owner, Engineer, or their authorized representatives for the duration of the Work. Engineer authorized representative may be present up to several days per week during active construction. The schedule and pickup location shall be arranged by the Engineer/authorized representative and the Contractor prior to mobilization. The Contractor shall provide a boat with an operator for the exclusive use of the Owner, Engineer, or their authorized representatives to tour the Project Site during the Work. The boat shall have up to six (6) passenger capacity with PFDs as required, Coast Guard certified, operable marine radio, all safety equipment required by the Coast Guard for the size and type of that boat, and adequate draft to access all areas of the Project Site. The Contractor shall supply the fuel and maintain the boat. All mechanical malfunctions of the boat shall be repaired within forty-eight (48) hours."
