Toro 3280D or equal

- Year Model: 2013 or newer
- Hours: Maximum of 1000 hours per unit.
- Condition: Mower should be in good working condition with no major damage.
- Engine: 3-cylinder, liquid cooled 24-horsepower diesel engine with 12-volt electric start.
- Radiator: Mid-mount industrial radiator with tube and fin construction: 8.5 fins per inch. System capacity approximately 7 quarts.
- Fuel capacity: 11 gallons
- Controls: Hand operated throttle, PTO switch, hydraulic lift /lower of implement, Foot operated forward/reverse traction pedal.
- Gauges: Fuel gauge, engine coolant temperature gauge and hour meter. Indicator light for high engine coolant temperature, low engine oil pressure, ammeter, glow plugs, high engine coolant temperature shutdown
- Electrical: 12-volt automotive type electrical system. 530 cold cranking amp battery. Dash mounted ignition switch, 40-amp alternator. PTO, seat, and traction interlock safety switches.
- Transaxle: Four-wheel drive, variable speed, axial position, hydrostatic in-line transmission; charge circuit hydraulics with 12-micron filtration provide hydraulic flow for power and implement lift. Transmission mates to drive axle; 6-quart oil capacity.
- Ground speed: 0 – 10 mph
- Implement lift: Two hydraulic left cylinders (2.75" bore).
- Steering: Steering valve controls single hydraulic steering cylinder. Steering system is single tie rod type. 14" tilt steering wheel.
- Tires/wheels: Two front traction drive tires: 23 x 9.5-12, turf tread, 4-ply rating. Two rear steering tires: 18 x 6.5-8, turf tread, 4 ply rating.

Brakes: Individual 7" x 1.75" drum type wheel brakes. Parking brakes on front traction wheels. Dynamic braking through traction drive.

Seat: Deluxe adjustable seat suspension.

Warranty: 1-year limited warranty covering engine/drivetrain/electrical/coolant

Mowing deck: 72-inch with 3-blades, 7-gauge steel, 5.5-inch deep, welded construction, reinforced with 12-gauge steel channels

Trimming ability: Deck is offset to the left of center 7".

Height of cut: 1 – 5 inches in 0.5-inch increments with spacers on the caster shafts.

Cutter drive: Isolation mounted PTO driven gearbox with 1.26:1 spiral bevel gears. "BB" hex section belts to spindles. 1.25" diameter spindle shafts, protected by rugged conical spindle housing, turn on two greaseable tapered roller bearings (greaseable from top of deck). A positive splined connection attaches pulleys to spindle shafts.

Caster Wheels: Two front and two rear caster wheels consisting of hard rubber with roller bearings

Deck Covers: Quick-release covers.

Delivery: Vendor will be responsible deliver to Azalea City Golf Course.

Vendor must have a full-service dealer location no more than 75 miles of the City of Mobile that is (1) capable of making any and all repairs to this unit and (2) has an ample supply of commonly used parts in stock.

Vendor shall provide parts, service, and owner's manuals in both digital and printed formats.
