

## City of Mobile Addendum 1 Bid # 5732

## SOLAR LIGHTS AND SOLAR POLES

The following updates, clarifications, and amendments are made to the City's Request for Bids #5732 (RFB), Solar Lights and Solar Poles.

- 1. The due date for all written proposals remains 11:00 am, October 25, 2022.
- 2. The following additional information supplements the original RFB.
  - a. <u>Bidding and Award, page 2 of 5</u>: No local-Vendor price preference will be applied to the bid evaluation due to the potential use of federal funds.
  - b. <u>Bid Pricing, page 3 of 5</u>: Bidders may select to submit pricing only for the pole structure they wish to provide as a solution. Bidders must, however, submit an A, B, and C configuration pricing for their pole structure(s) offered. That is, bidders are not required to submit pricing for all pole-channel configurations, or for both pedestal and in-ground configurations. For example, a bidder may offer only a single channel pole in all configurations, or may offer only an in-ground pole in all configurations. Bidders may also bid alternative configuration equipment or design options that meet minimum City specifications.
  - c. <u>Bid submission documentation #3 and #4, page 4 of 5, and Performance</u> <u>Specifications #9</u>: Vendor/Bidder is to indicate how it proposes to support City installation of and operation of pole solution, included in its pole pricing. Support may include examples such as written instructions, videos, or remote or on-site technical assistance. Vendor/Bidder should indicate how it will deliver pole solution to City, City assembly expectations, and the instructions and support Vendor/Bidder will provide for the City in the assembly/installation process.
  - d. <u>Vendor Qualifications #1, and Bid submission documentation #2:</u> "Vendor" and "Bidder" documentation of previous experience may include experience of the prime Vendor/Bidder, or any vendor, supplier, or subcontractor of the prime Vendor/Bidder.
  - e. <u>Performance Specification #9</u>: The City is not seeking installation services, only provision of the pole and associated equipment, and support or instructions that allow for City installation and operation.

- f. <u>Luminaire Specification #2</u>: **This specification is amended to read:** *Lumen* output in minimum ambient lighting conditions shall be a minimum of 150 *lumens/watt and have a minimum of* <u>one-half foot-candle</u> across the entire ground path below and 50 feet on either side of pole along the trail. <u>The light</u> <u>level is to is to be maintained throughout the evening hours</u>.
- g. <u>Camera Specification</u>: Bidders are to supply the specified camera in their solution and their pricing.

3. Vendors/Bidders are encouraged to document in the bid submission areas when they may have uncertainty about City specifications, and any assumptions made.
