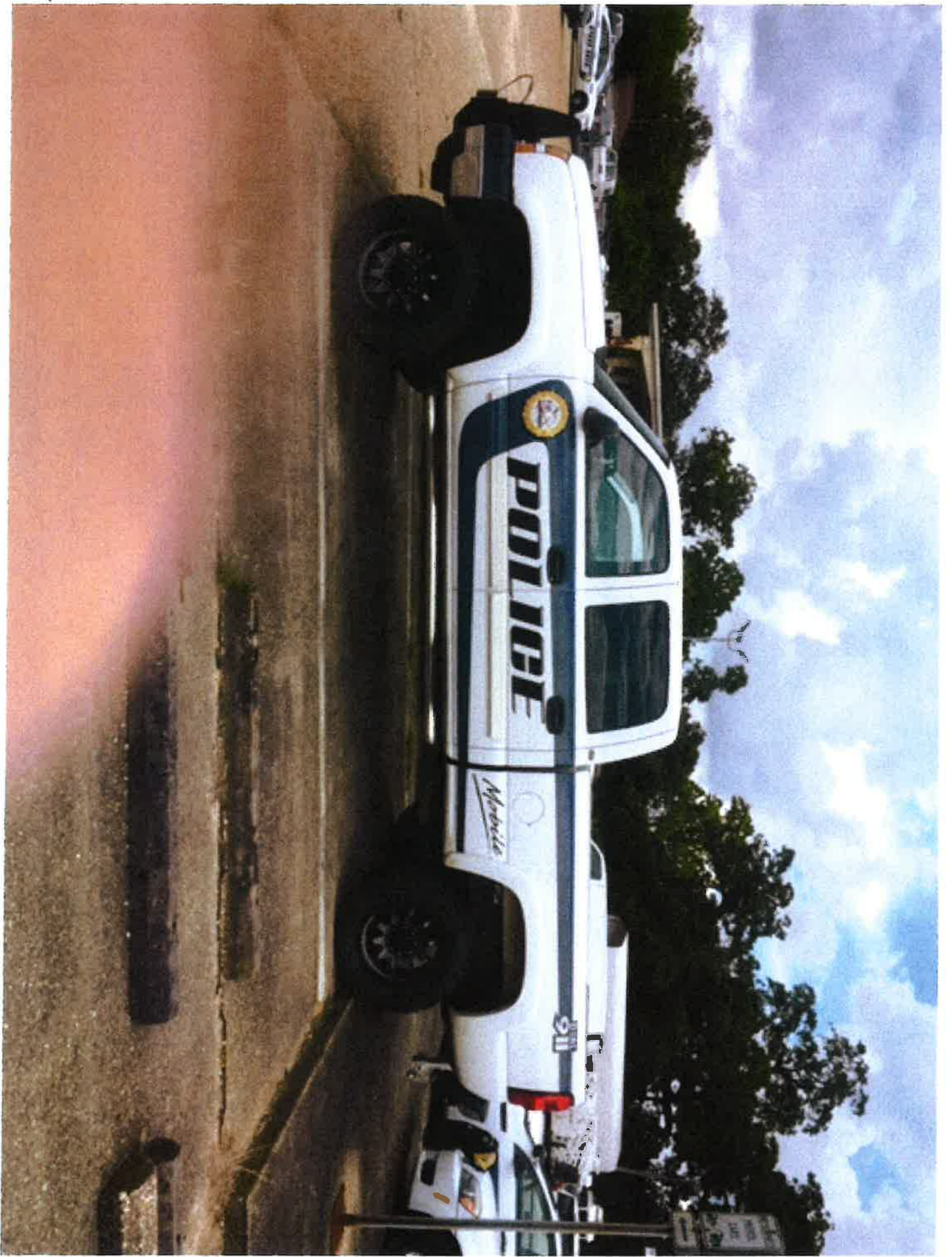

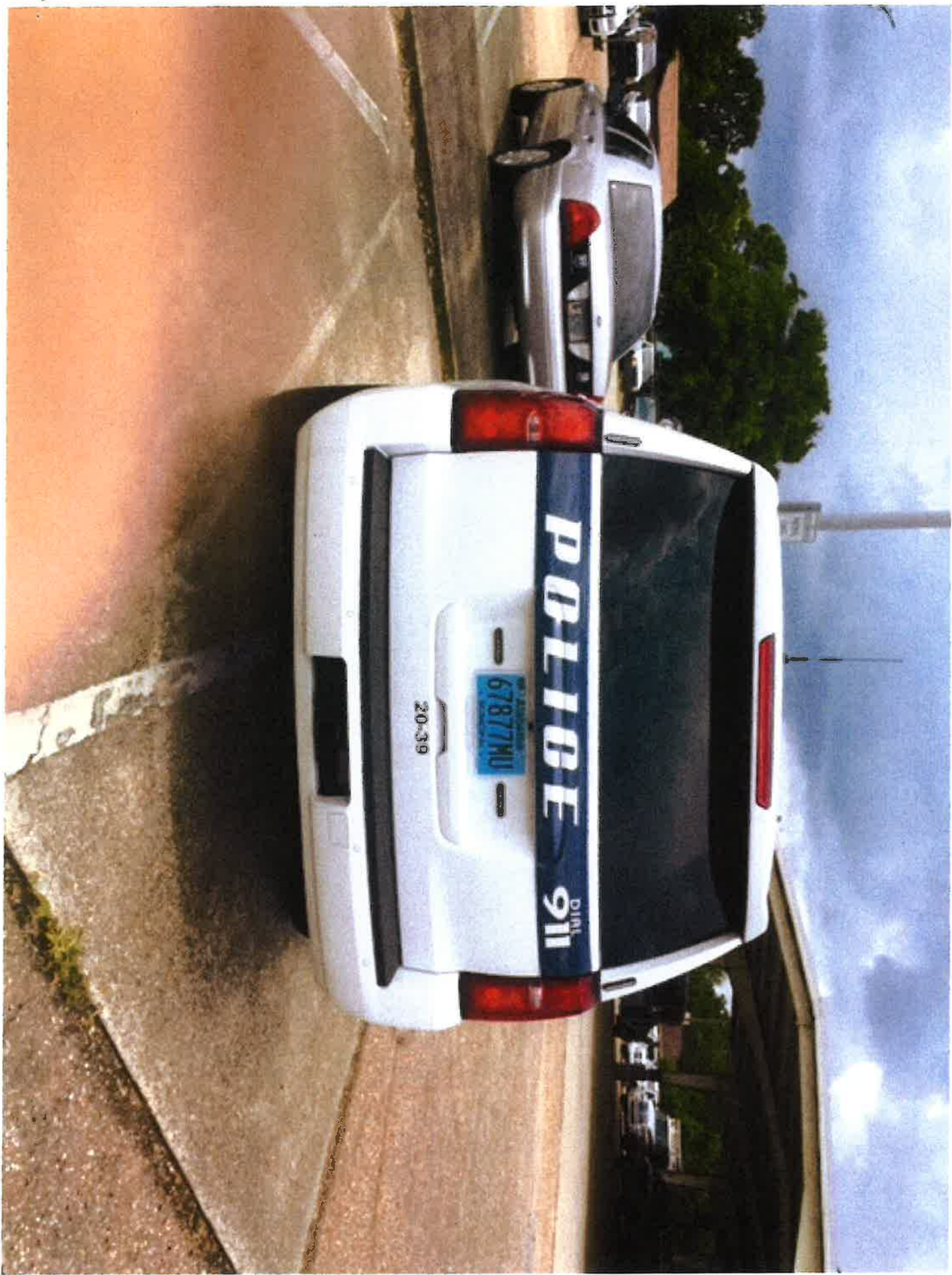














PROCUREMENT DEPARTMENT
