DOUBLE STACK TRANSPORT TRAILER FOR INFLATABLE BOATS WITH TWO (2) INFLATABLE BOATS SPECIFICATIONS

1 Each:

Double Stack Transport Trailer with black diamond plate accents for two (2) rescue boats with dual axles, surge brakes on both axles, Warn VR EVO-10,000 lb. electric winch to raise/lower upper rack powered by a heavy-duty battery, two (2) full-size spare tires and mounts, LED running lights, lifetime low-maintenance poly-runners, winch, and heavy duty jack stand. (All tires are 14" 10-ply tires.)

Galvanized coating – double of complete trailer.

Round 7-Pin trailer electrical connector with cable.

Ladder on driver side to access upper platform: mounted using a stand-off bracket to accommodate a hinged motor mount.

Expanded metal platform, inside tongue area.

Expanded metal platform back to the 1st cross-member.

Swinging spare motor mount on both sides. Hinges outward for easier and safer loading/unloading of spare motors.

Side mount spare tire carriers with spare tires.
