#### CATALYTIC CONVERTERS BID SPECIFICATIONS

- 1. The initial lot of Catalytic Converters and materials will be picked up by winning secondary recyclers within two (2) weeks of winning the bid.
- 2. The bid will be won by the qualifying bidder having the highest price total, based on the nineteen (19) Catalytic Converter categories and the minimum lot size.
- 3. The bidder must be capable of processing the Catalytic Converters, evaluating the correct category of the Catalytic Converters, and providing a spreadsheet with identifying numbers, make, model, category, and price according to current market value for the individual Catalytic Converter.
- 4. The bidder will be required to have a XRF Analyzer or similar device to determine the value of bottled converter contents, "precious metal contents," on site. Estimated contents and the value will be placed on the spreadsheet.
- 5. Payment will be made and received via wire transfer from a brick-and-mortar bank prior to leaving the Mobile Police Department Facility for all intact Catalytic Converters and Catalytic Converter materials. A wire transfer form, or payment via cellphone/online banking will not be accepted.
- 6. The calculation of the prices will be based on the current market value per individual Catalytic Converter.
- 7. The bid contract will be valid for one (1) year with the possibility of extension based on City of Mobile's needs and approval.
