5. *Minimum ground contact area of 5,100 sq. in.*
6. *Ground pressure no greater than 4 psi.*
7. *Operating weight no greater than 23,000 lbs.*
8. *6 way dozer blade with ability to.*
  - A. *Raise the blade at least 2 ft. 8in. above ground level.*
  - B. *Lower the blade at least 1 ft. 5in. below ground level.*
  - C. *1 ft. 5 in. range of tilt both right and left.*
  - D. *Angle the blade with at least 25 ° of angle from center to the right and left.*
9. *Minimum blade width and height 9Ft. 9in.(W) by 3ft. (H).*
