## QUESTIONS TO CITY OF MOBILE BID #6010 FOR RECYCLING EQUIPMENT RENTAL AND HAULING FOR CITY OF MOBILE RECYCLING CENTERS:

1. Will the City of Mobile consider an option based on using a recycling facility other than Baldwin County Recovery Facility? **NO**
2. Can we quote different haul rates for each of the recycling drop-off locations? **I WOULD SAY NO. IF WE GET DIFFERENT RATES FOR EACH SITE, WE COULD CONCEIVABLY HAVE THREE COMPANIES TO CONTEND WITH WHICH COULD COMPLICATE THINGS.**
3. Is the same-day service with notification before 10 a.m. a mandatory requirement? **YES**
4. Is the next day service before 7 a.m. with notification after 10 a.m. a mandatory requirement? **YES**
5. Is Saturday & Sunday service a mandatory requirement? **YES**
6. Can you provide any historical data on the number of hauls that have been diverted to a landfill due to the load being rejected for contamination or the facility being unavailable? **NOT RECENTLY. IT HAS HAPPENED ONCE IN THE LAST FOUR YEARS BECAUSE THE HAULER WAS UNABLE TO GET THE LOAD TO LOUISIANA. THAT WAS ABOUT A YEAR AND A HALF AGO.**
7. On Exhibit B: Total to Haul above 20 times/month. This should be the haul rate multiplied by 20, correct? **THAT IS CORRECT.**
8. What is the City of Mobile currently paying for the services requested in the bid? **SEE ATTACHED DATA.**
