1.1 GENERAL

- A. This Addendum is issued pursuant to the Instructions to Bidders and Conditions of the Contract. This Addendum serves to clarify, revise, and supersede information in the Project Manual, Drawings, and previously issued Addenda. Portions of the Addendum affecting the Contract Documents will be incorporated into the Contract by enumeration of the Addendum in the Owner/Contractor Agreement.

PART 3 - REVISIONS TO DIVISIONS 02 - 49 SPECIFICATION SECTIONS

- 3.1 Section 096723_Resinous Flooring, R1 AD03 dated June 2, 2023. Change as follows: (not reissued)
 - A. Article 1.8, A.: In two places change "(1)" to (3) three.
 - B. Article 2.1, A.: Add the following:
 - 1. Dex-O-Tex, Tek-Crete-TT, with, Tek-Crete-CP with all other comparable materials appropriate to the requirements
 - C. Article 2.1: Add the following:
 - F. Integral Wall Base: Construct integral wall base using same or comparable materials as used for resinous flooring.
 - 1. Select materials based on flooring manufacturer's recommendations for in service use equal to or greater than flooring including flooring's physical properties and finish color.
 - D. Article 2.2: Add the following"
 - C. Joint Sealant For Use In Cooler Freezer: Type recommended or produced by resinous flooring manufacturer, approved for food contact with in service use recommended for five degrees Fahrenheit below zero or lower.
 - D. Metal Cap Trim: Metal trim in configuration recommended by manufacturer.
 Metal shall have physical properties for corrosion and chemical resistance not less than Type 316 Stainless steel.


