- 4.01 Refer to attached drawing "A-1", entitled "GOVERNMENT STREET 3RD FLOOR FURNITURE", dated January 3, 2023. The furniture package shall be included in the base bid.
- 4.02 Refer to Sheet A1.6 "Partition Types". The wall sound insulation shall be Rockwool "Safe n Sound" 3 inch Fire Resistant Stone Wool Batt or approved equal.
- 4.03 Refer to Sheet A1.2 "Reflected Ceiling Plan". The Basis of Design acoustic tile for all areas shown shall be the following to match building standards:
 - A. Basis-of-Design Product: Subject to compliance with requirements, provide "Armstrong, Ultima, #1911" or comparable product by one of the following:
 - 1. Armstrong World Industries, Inc.
 - 2. CertainTeed Corporation
 - 3. Chicago Metallic Corporation
 - 4. USG Interiors, Inc.; Subsidiary of USG Corporation

 - 1. Type and Form: Type IV, wet-formed mineral fiber with vinyl-faced membrane; Form 2.
 - 2. Pattern: E.

- D. LR: Not less than 0.90.
- E. Edge/Joint Detail: Tegular
- F. Thickness: 3/4 inch.
- G. Modular Size: 24 by 24 inches.
- 4.04 Refer to Sheet A1.2 "Reflected Ceiling Plan". The Basis of Design above-ceiling acoustic insulation above all acoustic tile shall be unfaced Mineral-Fiber Blanket Insulation: BLANKETS WITHOUT MEMBRANE FACING, MINIMUM R-VALUE: R-19
- 4.05 Cross-referencing across all sheets and specifications, "Alternate #1" shall be omitted from the bid documents. In lieu of that proposed restroom work, only painting of the two existing restrooms is to be included in the base bid.
- 4.06 Cross-referencing across all sheets and specifications, "Alternate #2" shall consist of sanding the existing elevator cab walls and re-staining with 4 coats of polyurethane, removing the existing tile flooring and mortar and providing a new porcelain tile floor. Basis-of-Design for the porcelain tile shall be included in a subsequent addendum.

- H. Broad Spectrum Antimicrobial Fungicide and Bactericide Treatment: Provide acoustical panels treated with manufacturer's standard antimicrobial formulation that inhibits fungus, mold, mildew, and gram-positive and gram- negative bacteria and showing no mold, mildew, or bacterial growth when tested according to ASTM D 3273 and evaluated according to ASTM D 3274 or ASTM G 21.
