

Contractors' General Questions Received

1. We would like to request a two-week extension, if possible, In order for us to provide the best possible proposal? If not, we will take any extension that you will allow.

Response:

Sealed Bids will be received and clocked in until 2:15 PM local time, Wednesday November 01, 2023, in the office of the City Clerk, Government Plaza, 9th Floor South Administrative Tower, 205 Government Street, Mobile, Alabama 36602. Bis will be publicly opened and read at 2:30 PM local time, in the Atrium Lobby of Government Plaza.

2. We need to know the coating specifications for the pipe and sheets. Drawings only tell us the length, we need to know what material and the required thickness?

We need to know the lengths of the sheet piles.

Response:

Division 9 – Finishes: Technical Specification 09 97 13 "Coating of Steel Waterfront Structures" describes the required coating and thickness specifications for sheet piles. Pipe Piles are not required to be coated. Plan sheet S-201 & S-301 shows the cut off and tip elevations for the sheet piles & pipe piles.

3. Per drawing G-101 the owner is removing the pavers; will it be the responsibility of the contractor awarded this project to reinstall these pavers or is that part of a separate contract?

Response:

Reinstallation of the pavers is not a part of this contract and will be performed under a separate contract as a second phase to the improvements "Mobile Riverfront Developments - Park Improvements"

4. On drawing GA-101, is anything outside the new bulkhead included in this scope (seat wall, sidewalks, stamped concrete, gates, columns, etc) there are no details shown on these drawings for this work. We were not at the prebid and just want to verify.

Response:

No, outside of new bulkhead, the seat wall, sidewalks, stamped concrete, gates, columns, etc., are not a part of this contract and will be performed under a separate contract as a second phase to the improvements "Mobile Riverfront Developments - Park Improvements"
