The City of Mobile will receive quotes for the above stated project on Wednesday, June 17, 2020, no later than 2:00pm local time. Due to restricted access to Government Plaza offices during the Covid-19 crisis, it is recommended that quotes be emailed to the Building Services, Service Contract Administrator (ozzie@cityofmobile.org). Quotes may also be mailed or delivered in person to the following address:

City of Mobile, Building Services Department, South Tower, Room 546, Government Plaza 205 Government St./P.O. Box 1827, Mobile, AL 36633, Attention: Ozzie Elortegui

If delivered in person, it will be necessary to call the Building Services Department, Service Contract Administrator (Ozzie Elortegui at (251) 208-7639) to arrange a time. Enter Government Plaza from the South Joachim Street (west) entrance and meet the Service Contract Administrator at the security checkpoint.

A Pre-Bid conference shall be held at the Saenger Theater, 6 South Joachim Street, Mobile, AL 36602, on Tuesday, June 9, 2020 at 10:00a local time. A representative of the quoting company may be present at the meeting or contact the Service Contract Administrator at 251-208-7639, at least 2 days prior to the meeting, in order to coordinate attendance of the meeting by conference call. Regardless of attendance at the Pre-Bid meeting, Contractors are required to visit the sites prior to submitting a bid and include all costs associated with the project in their bids. Follow-up inspections will be allowable but only if scheduled in advance with the City of Mobile, Service Contract Administrator. Due to CDC/NIH Covid-19 guidelines, all company representatives are required to wear a mask/face covering when entering any City of Mobile Building and may be subject to temperature checks.

Visits to other locations must be scheduled in advance by contacting the Service Contract Administrator at 251-208-7639.

This is <u>NOT</u> a tax-exempt project. Quotes shall include all applicable sales and use taxes.

Scope of Work:

Work to be performed by Contractor under this Agreement shall consist of furnishing all labor, materials, insurance, tools, supplies and equipment necessary to perform repairs to the Fire Sprinklers and Backflow Preventers at Various City of Mobile Locations, as described in Exhibit A, Scope of Work, in accordance with the terms of the Contract.

Examination of Documents:

Before submitting a Quote, Contractors should carefully examine this Request for Quotes, visit the site of the Work, fully inform themselves as to existing conditions and limitations, and include in the Quote a sum to cover the cost of all items included in the Request for Quotes as necessary to perform the work. The submission of the Quote will be considered as conclusive evidence that the Contractor has made such examination.

Term of Agreement:

The Work shall commence on the date of written Notice to Proceed, issued by the Owner. The term of the Contract shall extend for Fifteen (15) working days from the date of the Notice to Proceed.

Contractor's Use of Premises:

Coordinate all work with the City of Mobile, Building Services Department, Service Contract Administrator, or other Building Services Department authorized representative (hereafter referred to as Service Contract Administrator). All Work shall be scheduled to minimize the disturbance and interruption of the facility, staff, and the general public.

Bid Security (If Quote/Bid is greater than \$15,000.00):

Cashier's Check drawn on an Alabama bank and made payable to the City of Mobile or Bid bond in the amount of 5% of the initial term (one year's) Bid Amount, but in no case more than \$10,000, is required to accompany Bid if Total Bid is \$15,000 or more. By submitting a Bid Security, the Bidder pledges to enter into a Contract with the City of Mobile on the terms stated in the Bid, and will, if required, furnish bonds covering faithful performance of the Contract and required insurance certificate. Should the Bidder refuse to enter into such Contract or fail to furnish such bonds or insurance, the amount of the Bid security shall be forfeited to the Owner as liquidated damages, not as a penalty. Bid Bond shall be valid for a minimum of sixty (60) days from the date of Bid. The Owner reserves the right to retain the security of all Bidders until the successful Bidder enters into the Contract or until sixty (60) days after Bid opening, whichever is sooner. Bonds must be issued by a Surety licensed to do business in the State of Alabama. If the project cost is more than \$50,000.00 the Surety must have a minimum rating of A/Class VI as reported by the latest issue of Best's Key Rating Guide Property-Casualty published by Alfred M. Best Company, Inc. Power of Attorney is required for all Bonds.

Quality Assurance:

For all work performed under this Section, use only skilled technicians who are thoroughly trained and experienced in the installation and training of this type of remediation. Technicians shall be properly supervised. Contractor shall have at least 3 years' experience in the installation and training on the type of repairs to fire sprinklers and backflow preventers.

All work shall be in accordance with National Fire Protection Association (NFPA) Code sections as listed above, the State of Alabama Fire Code, and all City of Mobile Regulations. Service Contractor shall be certified and hold a valid permit from the State of Alabama Fire Marshall, (a copy of a valid permit must be included in the bid documents). The work shall be performed by qualified technicians that have met the training requirements established by the State of Alabama Fire Marshall and the City of Mobile Fire Rescue Department.

Hours of Work:

The Owner shall not prohibit Contractor from performing work herein during a normal work day. For the purpose of this provision a "normal work day" is defined as any business day between the hours of 8:00 a.m. and 4:00 p.m.

Payments:

The Owner will pay the Contractor for actual work performed in accordance with the following:

- Payments will be made upon the completion of all work as specified.
- Original invoices shall be submitted to the Service Contract Administrator for review and approval.
- Payments shall be made in accordance with the approved Schedule of Values listed in the Agreement.

Termination:

The Owner or Contractor may terminate the Contract upon thirty (30) days written notice. The Owner shall pay only for work executed and proven loss with respect to materials, equipment, tools and reasonable overhead. The Owner shall not make payment to the Contractor for profit or damages as a result of terminating the Contract.

Insurance:

Contractor shall provide insurance in accordance with Exhibit 2, City of Mobile Insurance Requirements.

Form of Agreement:

The "Standard Contract Agreement between the City of Mobile and Contractor" (attached as Exhibit 3) shall be used.

General:

Requests for information (RFI's) shall be submitted in writing to the Service Contract Administrator no later than three (3) business day prior to the Quote submittal date. Responses shall be in the form of a written Addendum issued to all Contractors. Receipt of all addenda shall be acknowledged by the Contractor on the Quote forms. Failure to acknowledge Addenda may result in disqualification of the Quote.

A City of Mobile Business License is required and must be current at time of submitting a Quote, and throughout contract period.

- Within Ten (10) calendar days from the date of issuance of Contract forms for execution, the Contractor shall deliver to the City of Mobile the following documents:
 - 1. <u>Proof of enrollment in the Federal E-Verify program (see sample document, attached as Exhibit 1)</u>

- 2. <u>Certificate of Insurance along with ALL endorsements in accordance with City of</u> <u>Mobile Insurance Requirements (attached as Exhibit 2, with sample document)</u>
- 3. <u>Fully executed Agreement (see sample document, attached as Exhibit 3)</u>

Immigration Law: The Contractor agrees that it shall comply with all of the requirements of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, Act No. 2011-535, Alabama Code (1975) Section 31-13.1, et, seq., as amended by Act No. 2012-4-91. Compliance shall be evidenced by verification of enrollment in the E-Verify Program and documentation of enrollment shall be attached to the executed Agreement.

Anti-Boycott Statement:

- A. SCOPE OF WORK SR-022-20 – FIRE SPRINKLER AND BACKFLOW PREVENTER REPAIRS VARIOUS CITY OF MOBILE LOCATIONS June 3, 2020

<u>Scope of Services</u>: Furnish all labor, materials, tools, equipment, and supplies and to sustain all the expenses incurred in performing the work on the Fire Sprinklers and Backflow Preventers at Various City of Mobile Locations. Perform all repairs in accordance with National Fire Protection Association (NFPA) 13, 14, 15, 25 and any other applicable NFPA Codes.

All work shall be in accordance with National Fire Protection Association (NFPA) Code sections as listed above, the State of Alabama Fire Code, and all City of Mobile Regulations. Service Contractor shall be certified and hold a valid permit from the State of Alabama Fire Marshall, (a copy of a valid permit must be included in the bid documents). The work shall be performed by qualified technicians that have met the training requirements established by the State of Alabama Fire Marshall and the City of Mobile Fire Rescue Department.

1. Arthur R. Outlaw Mobile Convention Center, 1 South Water Street

- a. Install Twenty (20) chrome semi recessed plates that are missing at various locations in exhibit hall and 3rd floor (install only, plates are on location). Contractor to verify quantity.
- b. Replace Four (4) sprinkler heads that have been painted in the 3rd floor women's restroom. Contractor to verify type and size.
- c. Replace Four (4) sprinkler heads that have been painted in the 3rd floor men's restroom. Contractor to verity type and size.
- d. Install Ten (10) chrome semi recessed plates that are missing in the Kitchen (install only, plates are on location). Contractor to verify quantity.
- e. Repair domestic backflow preventor. Check valve #1 leaked by and the Relief valve does not hold 2psi.

2. Azalea City Golf Club, 1000 Gaillard Street

- a. Approximately Fifteen (15) sprinkler heads loaded with dust and require cleaning (Contractor to verify).
- b. Install One (1) FDC sign for Fire Department Connection in front of building.

- a. Install One (1) 1.5" standard pipe thread to 1.5" national hose tread adaptor on hose station #5 (adaptor missing)
- b. Perform 5-year inspection

- a. Replace Four (4) brass check valves on backflow preventor. Contractor to verify make/model/size.
- b. Loaded heads throughout the facility require dusting (Contractor to verify quantity and lift requirements)

14. Mobile Civic Center, 401 Civic Center Drive

- a. System #1 (Arena) install One (1) alarm line test sign
- b. System #1 (Arena) install One (1) main drain sign
- c. System #1 (Arena) install One (1) inspectors test sign

17. Public Safety Complex (Fire Station 26), 8080 Airport Blvd

a. Replace test cock valves on backflow preventor(s) – Contractor to verify size and quantities

18. Saenger Theater, 6 South Joachim Street

- a. Replace fifteen (15) sprinkler heads that are painted throughout the theater. Contractor to verify quantity and size.
- b. Replace two (2) sprinkler heads on 3rd floor that are over 50 years old. Contractor to verify size.
- c. Replace seventeen (17) escutcheon plates for above sprinkler head replacements. Contractor to verify type.
- d. Replace four (4) missing sprinkler heads in head box located in basement. Contractor to verify type/size.
- e. Replace 8-in control valve OS&Y in basement that has slow leak. Contractor to verify make/model.

19. Sullivan Recreation Center, 351 North Catherine Street

a. Install One (1) control valve sign

20. Tardy Cottage, 104 South Lawrence Street

- a. Install relief pressure switch
- b. 5 Year Obstruction Must comply with NFPA-25 for internal pipe obstruction inspections

21. West Regional Library, 5555 Grelot Road

- a. 1st floor ("Peanut Free Area") has Four (4) loaded white 155F QR ¹/₂" semi recessed pendants. Clean and/or replace if cleaning is inadequate.
- b. 1st floor (Young Adult Area) Replace ³/₄" 155F QR white pendant shows signs of leakage (Contractor to verify if down pipe to pendant above ceiling tile is leaking and replace if necessary)
- c. Display area by front desk head has sheet rock mud on head and is missing plate cover. Replace head and plate cover.
- d. 1st floor behind front desk two (2) loaded white 155F QR ¹/₂" pendants. Clean and/or replace if cleaning is inadequate.
- e. Quantity Five (5) standard response ¹/₂" heads and one (1) quick response ³/₄" head mixed in with ¹/₂" quick response heads at the main entrance. Replace with Six (6) ¹/₂" quick response heads to make them all the same.
- f. 2nd floor Replace Three (3) painted chrome 155F QR pendant semi recessed heads around open floor area by elevators.
- g. 2nd floor Replace Two (2) ³/₄" white 155F QR semi recessed heads that show sign of leakage.
- h. 2nd floor staff area Replace One (1) missing chrome semi recessed plate
- i. 2nd floor maintenance office Replace One (1) missing chrome semi recessed plate

Note - Contractors shall field verify each condition as listed above before submitting a quote.

Additional Services:

If, during the course of the work, an unforeseen condition arises, the Contractor will immediately provide the Owner's Project Manager with a written report to include detailed description and cost estimate for additional work required. No work may be performed without written approval by Owner.

City of Mobile Insurance Requirements Contractor

<u>Insurance</u> – For the duration of this agreement, the Contractor shall maintain the following minimum amounts for this project:

- A. Workers' Compensation/Employer's Liability:
 - Workers' Compensation insurance in the amounts required by all applicable laws, rules or regulations of the state of Alabama.
 - Employer's Liability with limits of not less than:

- Borrowed Servant/Alternate Employer endorsement in favor of City of Mobile.
- B. <u>Comprehensive General Liability Insurance:</u>
 - Comprehensive General Liability (occurrence form) including coverage for products/completed operations, independent contractors, blanket contractual liability specifically covering the obligations assumed by Contractor.
 - Limit of Liability: \$1,000,000 combined single limit of liability each occurrence bodily injury or property damage.
 - 3. General Aggregate Limit shall apply on a "Per Project" Basis.
- C. <u>Automobile Liability Insurance:</u>
 - Automobile Liability Insurance to cover any auto, including all owned, nonowned, and hired vehicles, with a \$1,000,000 combined single limit of liability each accident for bodily injury and/or property damage.
- D. <u>Excess/Umbrella Liability Insurance</u>
 - Providing following form coverage for Employer's Liability, Comprehensive General Liability, and Automobile Liability.
 - Limit of Liability: \$2,000,000 combined single limit of liability each occurrence for bodily injury and/or property damage.

WITNESSETH, that this Contractor and City, for the considerations stated herein, agree as follows:

ARTICLE 1. Statement of Work to be Performed:

1.1 Work to be performed by Contractor under this Agreement shall consist of furnishing all labor, materials, insurance, tools, supplies and equipment necessary to perform repairs to the Fire Sprinkler and Backflow Preventers at Various City of Mobile Locations, as described in Exhibit A, Scope of Work, in accordance with the terms of the Contract.

ARTICLE 2. Term of Contract:

2.1 The Work shall commence on the date of written Notice to Proceed, issued by the Owner. The term of the Contract shall extend for a total of Fifteen (15) working days.

ARTICLE 3. Contract Sum:

3.1 The City shall pay the Contractor, in current funds, the sum as follows:

The City of Mobile reserves the rights to add, remove and modify services, as needed during the term of this Agreement.

All work shall be in accordance with National Fire Protection Association (NFPA) Code sections as listed above, the State of Alabama Fire Code, and all City of Mobile Regulations. Service Contractor shall be certified and hold a valid permit from the State of Alabama Fire Marshall, (a copy of a valid permit must be included in the bid documents). The work shall be performed by qualified technicians that have met the training requirements established by the State of Alabama Fire Marshall and the City of Mobile Fire Rescue Department.

ARTICLE 4. Payments:

4.1 The City will pay the Contractor on account of the Contract as follows:

- A. Payment will be made upon completion of the work as specified.
- B. Original invoices shall be delivered to the Owner's Project Manager for review and approval following completion of Work.

C. Payments shall be made in accordance with the accepted Schedule of Values listed in the Contract Documents.

ARTICLE 5. Termination of the Contract:

5.1 The Owner or Contractor may terminate the Contract upon thirty (30) days written notice. The Owner shall pay the Contractor for work executed and for proven loss with respect to materials, equipment, tools and reasonable overhead.

5.2 The Owner shall not make payment to the Contractor for profit and damages, as the result of terminating the Contract.

ARTICLE 6. Contract Documents:

6.1 The contract documents consist of this Agreement, Addenda issued prior to the execution of the Contract, The Contractor's Quote as accepted by the City, other documents listed in this Agreement, and Modifications issued after the execution of this Agreement, all of which form the Contract, and are as fully a part of the Contract as if attached to this Agreement or repeated herein. An enumeration of the Contract Documents, other than a Modification, appears below:

- 3. Scope of Work, Exhibit A, dated June 3, 2020
- 4. This Instrument (Agreement)

- 6. Certificate of Liability Insurance with Endorsements

ARTICLE 7. Insurance:

7.1 Required coverage:

7.1.1 For the life of this Agreement, Contractor shall acquire and maintain in full force and effect no less than the following liability and comprehensive insurance issued by a company licensed and qualified to do business in the State of Alabama, which such insurance shall name the City of Mobile as an additional insured, and shall attach to this contract as proof thereof a certificate of insurance issued by an agent licensed and qualified to do business in the State of Alabama:

- A. Comprehensive General Liability (occurrence form) including coverage for premises, products and complete operations, and blanket contractual liability, specifically covering the obligations assumed by the Contractor.
 - 1. Bodily injury liability:
 - \$1,000,000 each person
 - \$1,000,000 each occurrence
 - 2. Property damage liability \$1,000,000 each occurrence.
 - 3. Or, in lieu of (1) and (2) above:
 - Bodily injury and property damage combined -\$1,000,000 per occurrence
 - 4. General Aggregate limit shall apply on a "Per Project" Basis.

- B. Comprehensive Automobile Liability Insurance to cover any auto, including all owned, non-owned, and hired vehicles.
 - 1. Bodily injury liability:
 - \$1,000,000 each person
 - \$1,000,000 each occurrence
 - 2. Property damage liability \$1,000,000 each occurrence.
 - 3. Or, in lieu of (1) and (2) above)
 - Bodily injury and property damage combined \$1,000,000 per occurrence
- C. Excess/Umbrella Liability insurance

1. \$2,000,000 combined single limit of liability each occurrence for bodily injury and/or property damage.

2. Providing following form coverage for Employer's Liability, Comprehensive General Liability and Automotive Liability.

D. Workers' Compensation insurance - in the amounts required by all applicable laws, rules or regulations of the state of Alabama.

7.1.2 If the certificate of insurance referenced in this Agreement does not evidence insurance of owned vehicles, said certificate and this sentence shall evidence the Contractor's covenant that it does not own any vehicles and that it will not purchase or obtain any vehicles during the term of this Agreement. Said certificate shall require that said insurance coverage will not be altered or terminated unless City shall have been given written notice of such alteration or termination delivered to City not less than thirty (30) days before the effective date of such alteration or termination.

7.1.3 Waiver of Subrogation - all policies of insurance shall be endorsed to waive rights of subrogation in favor of City of Mobile.

7.1.4 Additional Insured - all policies of insurance, except those referenced under 7.1.1 D, shall be endorsed to name City of Mobile as an Additional Insured

7.1.5 Primary Insurance - all policies of insurance, except those referenced under 7.1.1 D, shall be endorsed to provide that all such insurances are primary and non-contributing with any other insurance maintained by City of Mobile.

7.1.6 Certificates of Insurance - prior to execution of the Agreement, Contractor shall deliver to the City of Mobile certificates of insurance certifying the existence and limits of the insurance coverages, noting applicable endorsements, described above and shall deliver same and renewals thereof to the City of Mobile. The certificates shall provide that such insurance shall not be subject to cancellation, non-renewal nor material change without 30 days or more (except 10 days for non-payment) prior written notice thereof to the City of Mobile.

ARTICLE 8. Miscellaneous Provisions

8.1 Breach of Contract: In the event of any breach or apparent breach by Service Contractor of any of its obligations under the terms of this Agreement, and in the further event that City shall engage the services of any attorney to protect or to enforce its rights with respect to said breach or apparent breach, then and in those events, Service Contractor agrees to pay and to reimburse any and all reasonable attorneys' fees and expenses which City may incur with respect to City's enforcement of this Agreement; regardless of

whether said attorneys' fees and costs shall be incurred in connection with any litigation or in connection merely with advice and representation provided without litigation.

8.2 Indemnification: Service Contractor agrees to indemnify and hold the City, its elected officials, officers, agents, and employees, whole and harmless from all costs, liabilities and claims for damages of any kind (including interest and attorneys' fees) arising in any way out of the performance of this Agreement and/or the activities of Service Contractor, its principals, directors, agents, servants and employees in the performance of this Agreement, for which the City is alleged to be liable. In the event that the City, through no fault of its own, is made a party to any lawsuit or legal proceeding arising in any way from this Agreement or any activities conducted pursuant thereto, Service Contractor hereby agrees to pay all of City's costs of defense, including but not limited to all attorneys' fees, court costs, expert witness fees and other expenses, through trial and, if necessary, appeal. This section is not, as to third parties or to anyone, a waiver of any defense or immunity or statutory damages cap otherwise available to Service Contractor or City, and these defenses and matters may be raised in the City's behalf in any action or proceeding arising under this Agreement.

8.3 Entire Agreement: This Agreement is the final expression of the agreement between the parties, and the complete and exclusive statement of the terms agreed upon, and shall supersede all prior negotiations, understandings or agreements. There are no representations, warranties, or stipulations, either oral or written, not contained herein.

8.4 Governing Law and Venue: This Agreement shall be governed by the laws of the State of Alabama, and the appropriate venue for any actions arising out of this Agreement shall be a court of proper jurisdiction in Mobile, Alabama.

8.5 Licenses, permits, etc.: Service Contractor shall obtain, at its own expense, all necessary professional licenses, permits, insurance, authorization and assurances necessary in order to abide by the terms of this Agreement.

8.6 No Agency Relationship Created: Service Contractor, in the performance of its operations and obligations hereunder, shall not be deemed to be an agent of the City but shall be deemed to be an independent contractor in every respect and shall take all steps at its own expense, as City may from time to time request, to indicate that it is an independent contractor. City does not and will not assume any responsibility for the means by which or the manner in which the services by Service Contractor provided for herein are performed, but on the contrary, Service Contractor shall be wholly responsible, therefore.

8.7 Anti-discrimination: Service Contractor shall comply with all Federal, State and local laws concerning nondiscrimination, including but not limited to City of Mobile Ordinance No. 14-034 which requires, *inter alia*, that all contractors performing work for the City of Mobile not discriminate on the basis of race, creed, color, national origin or disability, require that all subcontractors they engage do the same, and make every reasonable effort to assure that fifteen (15%) percent of the work performed under contract be awarded to socially and economically disadvantaged individuals and business entities.

8.8 Assertion of Rights: Failure by the City to assert a right or remedy shall not be construed as a waiver of that right or remedy.

8.9 State of Alabama Immigration Law: By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for

employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

8.10 Public Contracts with Entities Engaging in Certain Boycott Activities: By signing this contract, the Service Contractor further represents and agrees that it is not currently engaged in, nor will it engage in, any boycott of a person or entity based in or doing business with a jurisdiction with which the State of Alabama can enjoy open trade.

8.11 CDC/NIH Covid-19 Guidelines are in effect. The Service Contractor will adhere to current guidelines as directed by the City. All Service Contractor's personnel shall wear a face mask/face covering at all times while in a City of Mobile building, adhere to current social distancing guidelines, and note that temperature checks may be conducted.
