John Deere 4052M or equal

Engine: 4-cylinder, liquid-cooled, turbo charged, diesel engine, 39-horsepower rated at PTO, 127 cubic inches displacement, 13.8 gallon fuel tank

Transmission: 4-wheel drive, 12F/12R Power Reverser, wet disc clutch, cruise control

Hydraulics: category I, 3-point hitch lift with a capacity of 2500 pounds, one set of standard rear remote hydraulics and one “power beyond kit” (which provides continuous hydraulic power to implements which have an independent open-center control valve, this includes rear mounted hydraulic couplers and hose)

Power Take Off: rear mounted, 540 rpm, live independent

Controls: hand operated throttle, hand operated lift /lower lever for rear implements, electrohydraulic PTO push/pull type switch
