The Chairman, Mr. Terry Lilley, called the meeting to order at 9:09 a.m.

The Chairman presented the **minutes of the regular Board meeting of February 22, 2017.** Captain Lee moved for approval, with a second from Captain Jackson, the minutes were approved as written and distributed.

The Chairman presented items 3 through 8 on the agenda for approval. *On a motion by Captain Lee seconded by Captain Jackson, the Board approved the following:* 

Personnel Action Notice of DROP retirement effective April 1, 2017 submitted by **Fire Service District Chief Billy G. Roach, Mobile Fire Department.** As of March 31, 2017 District Chief Roach will be 58 years old and will have served 26.51 years. He has elected the 100% joint and survivor annuity option with the 'pop-up' feature;

Personnel Action Notice of DROP retirement effective April 1, 2017 submitted by **Firefighter Robert J. Wilkins, Mobile Fire Department.** As of March 31, 2017 Firefighter Wilkins will be 55 years old and will have served 26.69 years. He has elected the 100% joint and survivor annuity option with the 'pop-up' feature;

Personnel Action Notice of DROP retirement effective April 1, 2017 submitted by **Fire Service Driver James L. Young, Mobile Fire Department.** As of March 31, 2017 Driver Young will

be 58 years old and will have served 24.52 years. He has elected the 100% joint and survivor annuity option with the 'pop-up' feature;

Invoice No. 009-0217 dated February 17, 2017 in the amount of \$20,000.00 submitted by Southern Actuarial Services Company, Inc. for actuarial valuation as of October 1, 2016; and

Approve payment in the amount of \$391,181.57 to Corrum Capital Management for their Capital Call due March 22, 2017.

The secretary provided each Board member with a list of the **requests for refund**. On a motion by Captain Lee, seconded by District Chief Lami, the Board approved refunds totaling \$76,148.22 as follows:

Mr. Anthony Williams and Mr. Derek Power gave a short presentation on behalf of Schroders. They answered questions posed by the Board and Mr. Druhan. *The Chairman thanked Mr. Williams and Mr. Power on behalf of the Board, and they departed.* 

Captain Lee moved to hire Schroders' commingled fund with 0.60% basis points after Mr. Druhan does his legal review of their contract. Mr. Wesch seconded the motion, and the motion carried.

Captain Lee moved to terminate Allianz and to use those monies to fund WCM and Schroder. Mr. Wesch seconded the motion, and the motion carried.

## **Unfinished Business:**

• Mr. Druhan presented a resolution to the Board for approval to get Attorney General Opinion. District Chief Lami moved for approval seconded by Captain Jackson and the motion carried.

## **New Business:**

• Captain Lee moved to accept the RFP for consultant and to move forward with changes. Mr. Roberts seconded the motion, and the motion carried.

There being no further business to come before the Board, on a motion by District Chief Lami, seconded by Captain Lee, the meeting adjourned at approximately 11:22 a.m.
