The Chairman, Mr. Lilley, called the meeting to order at 9:05 a.m.

Captain Hodge seconded the motion, and the motion carried.*

Kent,** of his intent to leave the Fire Department and withdraw from the DROP to enter active retirement effective May 31, 2015. *Captain Connick moved for approval. Captain McLarty seconded the motion, and the motion carried.* 

The Chairman presented the Personnel Action Notice of retirement effective May 15, 2015 submitted by **Deputy Fire Service Chief Mark A. Hansberry, Mobile Fire Department.** As of May 14, 2015 Deputy Chief Hansberry will be 50 years old and will have served 26.88 years. The Chairman presented the Personnel Action Notice of retirement effective June 1, 2015 submitted by **Police Sergeant Joseph Sampson, Jr., Mobile Police Department.** As of May 31, 2015 Sergeant Sampson will be 63 years old and will have served 20.04 years. He has elected the 100% joint and survivor annuity option with the 'pop-up' feature. *Captain Hodge moved for approval. Chief Barber seconded the motion, and the motion carried.* 

The Chairman presented the Personnel Action Notice of DROP retirement effective June 1, 2015 submitted by **Fire Service Driver Phillip W. Richardson, Mobile Fire Department.** As of May 31, 2015 Driver Richardson will be 50 years old and will have served 29.01 years. He has elected the maximum option with no benefits payable to a survivor. *Captain McLarty moved for approval, with a second from Mr. Singleton the motion carried.*
