The Chairman, Mr. Terry Lilley, called the meeting to order at 8:30 a.m.

The Chairman presented the **minutes of the regular Board meeting of September 23, 2015.** Captain Lee moved for approval, with a second from Mr. Smith, the minutes were approved as written and distributed.

The Chairman presented a Personnel Action Notice of DROP retirement effective November 1, 2015 submitted by **Fire Service Driver Coby E. Wilkins, Mobile Fire Department.** As of October 21, 2015 Driver Wilkins will be 60 years old and will have served 20.01 years. He has elected the maximum option with no benefits payable to a survivor. *Captain Connick moved for approval, with a second by Captain Hodge, the motion carried.*

The Chairman presented a request from Captain Lee to become a member of NCPERS again at the rate of \$250.00 annually. *Captain Connick moved for approval, with a second by Captain Lee, the motion carried.*
